STEPHENS, Justice. David L. Austin appeals his jury conviction of the offense of possession of less than 28 grams of cocaine, a controlled substance. He complains that the court erred in failing to charge the jury on the guestion of possession, failure to grant a mistrial because of certain improper questions propounded by the prosecuting attorney, and failure to grant a hearing on defendant's motion for discovery. We affirm the conviction. In his first point of error, appellant contends that the court erred in failing to charge the jury on the issue of possession, which appellant claims was raised by the evidence. Appellant directs our attention to his objections to the charge and in particular to the paragraph which tracked the statutory language of section 481.115(b) of the Health & Safety Code. The court's charge authorized the jury to convict if it found that appellant "intentionally and knowingly... possess[ed] a controlled substance, namely [cocaine]...." In his statement of facts, appellant states that the "evidence at trial showed that he had no possessory interest in the substance." The statement fails to show how the issue of possession of the cocaine arose in the trial of the case. Appellant's only objection to the charge was that, as given, the charge was not complete. No request to charge on the issue of possession was made, nor was the court requested to give such a charge. In his brief, appellant has directed our attention to the testimony of three witnesses, Frank Stephens, Donna Gibbons, and Beverly Westbrook, at trial. The substance of these witnesses' testimony is that the appellant obtained possession of the cocaine from another
